Fred treated everyone that came through the doors with the utmost professionalism, respect, and most importantly, as if family.

Countless life long friendships were forged over his years with **Family Investors Company**. With the honorable distinction of being the oldest continually operating brokerage firm in central New Jersey, Fred was proud that even in times of unrest in the financial industry, and personal health struggles, the doors have never shut.

The American flag has always been prominently displayed outside our building, alongside a sign that reads **"We don't plan to fail, but we do fail to plan"** two important symbols of Fred's company's history. Bravely serving as an Air Force pilot during the Korean War, Fred was encouraged by a fellow soldier to invest in a mutual fund. Pleased to have the money upon returning home, the idea to start a financial planning business was forged. He was acutely aware that many of his fellow soldiers would return home to families and not have a plan to provide for them and their futures. This, an unacceptable prospect, set in motion his goal to help others, and his community, prepare for successful futures.

Fred's commitment to serving his clients and community was only rivaled by his passion for educating on the importance of proper financial planning and his deep devotion to faith. A past President of Rotary, he had a strong belief in **"Service above Self"**.

Fred also received the prestigious Matty Matthewson award in 2001 as Rotary district 7510's Rotarian of the year. Fred educated many on the importance of financial planning. As a columnist for a weekly newspaper, he wrote **"Investors Corner"** and hosted a WERA radio program **"Money Line."** He also was an instructor for local adult schools and colleges and a guest speaker for both civic and

professional groups.

Over the years, Fred was asked to participate in countless local causes. While not one to say no, he was wise enough to know when the talents and experiences of others were better suited. He used these opportunities to inspire others and his beloved family to get involved. Boasting an arsenal of **10 siblings, 6 children, 2 step-children and 23 grandchildren**, he was never short on talent to draw on. When Fred would encourage family and friends alike to step up and serve their community, or rally to help a local cause, one happily obliged.
